**Rules and Regulations**  
**Connecticut Academy of Nutrition and Dietetics**

**1. CT ACADEMY**

Reference to “CT Academy” means Connecticut Academy of Nutrition and Dietetics, acting through its officers, directors, members, committees, agents, or employees.

**2. PERMISSIBLE EXHIBITS**

- A. Participating firms are limited to those who display products and services that support the development of the dietetics profession. In order to preserve the educational value of the exhibit program, the CT Academy will examine all applications and evaluate the proposed exhibits to determine whether they satisfy basic criteria.
- B. Exhibitors making product statements of properties, performance, nutrient values, beneficial results, etc., should be such that they can be verified by adequate data available in well-accepted, peer-reviewed literature acceptable to the CT Academy.
- C. The CT Academy reserves the sole and absolute right to determine which firms and products are appropriate in its judgment for inclusion in the Exhibition and to refuse, cancel, or restrict any applicant, Exhibitor, or exhibit which the CT Academy considers undesirable for any reason.

This provision applies to Exhibitor’s conduct, articles, printed matter samples, questionnaires, celebrities, or any other item the CT Academy deems objectionable or unacceptable.

If the CT Academy decides that any of these do not meet its standards or is not suitable, the Exhibitor must at once comply with the CT Academy’s demands or can withdraw and, if appropriate, receive back the rental fee paid, prorata for the unused time.

All first time exhibitors will be reviewed prior to acceptance for exhibiting.

- D. At the request of the CT Academy, made at any time before or during the Exhibition, Exhibitor must promptly furnish the CT Academy with sample products, packages, labels, advertising, and/or literature that would be or is being distributed before Exhibitor will be eligible to participate or continue in the Exhibition.

**3. PERMISSIBLE BOOTH ACTIVITY**

- A. All business activities of the Exhibitor at the Exhibition Hall must be within the Exhibitor’s allotted exhibit space.
- B. Distribution of food or beverages in Exhibitors’ booths: Only food and beverage manufacturers may serve sample size 4 oz. portions of their own products. They may not obstruct the aisle.
- C. Equipment manufacturers who require food or beverage products served to demonstrate their equipment may do so only in sample sizes.
- D. Alcoholic beverages may not be displayed or served in any booth or elsewhere in the Exhibition unless approved for distribution in writing by the CT Academy and served from within the Exhibitor’s booth.
